

Diaspora, Women, and Film: Unveiling Feminist Narratives in Nollywood

Abstract

The African diaspora emerges as a profound site of storytelling and cultural negotiation in the interplay between identity, migration, and creative expression. This intersection is vividly captured through Nollywood, Nigeria's dynamic film industry, where stories of diaspora and womanhood are brought to life, challenging conventions and celebrating resilience. Within this cinematic space, women's narratives in the diaspora stand out, offering unique perspectives on migration, identity, and empowerment. This paper explores how Nollywood is a lens for examining the feminist dimensions of diasporic experiences. It interrogates the representation of women navigating transnational spaces, their redefinition of belonging, and their roles as agents of cultural and personal transformation. By focusing on feminist narratives, this study sheds light on the complexities of gender, intersectionality, and diaspora in Nollywood films. Aligned with the conference theme, "African Diasporic Literature & Film," this paper underscores the connection between literary and cinematic storytelling as vehicles for articulating the diverse realities of African diasporic identities. Nollywood, through its vibrant storytelling, acts as a bridge between the literary and visual, creating a space where feminist voices within the African diaspora are not only heard but celebrated.

The Nollywood Diaspora: Nigerians Abroad

In the context of this paper and Nollywood Diaspora, a Diaspora film refers to a genre of movies that specifically explore the experiences of Nigerians living overseas. These films are produced through collaborations between the Nollywood industry and African immigrant communities in various countries such as Europe, North America, Brazil, China, and elsewhere. These narratives fluctuate between the perspectives of settled expatriates and those grounded at home in Nigeria. Through this lens, we explore questions of identity, belonging, and cultural hybridity. (Haynes 2013 p.77)

Nigerians living abroad have a strong affinity for Nollywood films and several factors contribute to this enduring interest. First is nostalgia and connection. Nollywood movies serve as a virtual bridge connecting Nigerians in the diaspora to their homeland. Viewing Nigerian movies is like a virtual journey back home. For Africans in the diaspora, it's a trip down memory lane—a way to reconnect with their cultural roots and reminisce about life in Nigeria. These films often depict familiar landscapes, clothing styles, body language, houses, and dances. Watching them can evoke a sense of nostalgia. Secondly, the films serve as 'group therapy' because Nollywood films provide a sense of community and shared experience. Watching these movies becomes a form of group therapy for those far from home, allowing them to feel connected to their fellow Nigerians across borders.

Thirdly is Cultural Familiarity: Although an increasing number of Nollywood films are set in locations abroad, they remain firmly grounded in Nigerian cultures. The portrayal of familiar customs, languages, and everyday life resonates with the diaspora audience, reinforcing their sense of identity and belonging.

The fourth reason is Educational Value: Many viewers emphasize the moral lessons embedded in Nollywood films. These movies often weave tales that portray cultural norms, family dynamics, and societal issues and messages that help Nigerians living outside to teach their children. As a result, they are seen not only as entertainment but also as educational tools that convey important messages.

The fifth reason is Language and Identity: While some viewers prefer films in their native languages (such as Yoruba, Hausa, Igbo, Edo, and Itsekiri), a significant portion of the diaspora audience watch Nollywood movies in English. This choice allows them to maintain a connection with their Nigerian identity while also appealing to a broader audience who were not born in Nigeria or do not understand the local languages. There are other reasons as stated below.

The sixth reason is Global Reach and Distribution: The diaspora has facilitated the distribution of Nollywood films beyond Nigeria's borders. Nigerian immigrants in Europe, North America, and other regions actively promote and consume Nollywood content. Nollywood movies are now screened in international film festivals, reaching diverse audiences. This exposure has elevated the industry's profile and encouraged collaborations with filmmakers worldwide.

Another reason is Cultural Hybridity: Nollywood diaspora filmmakers blend Nigerian storytelling with their host countries' cinematic sensibilities. This fusion results in unique narratives that resonate with local and global viewers. Themes of migration, identity, and belonging emerge as characters navigate the complexities of living abroad. These stories reflect the diaspora's experiences and challenges. Financial Investment is also a tenable factor as Nigerian expatriates invest in

Nollywood productions, injecting capital and expertise. Their financial contributions bolster the industry's growth and sustainability. Co-productions between Nollywood and diaspora filmmakers create synergies, pooling resources and talents for ambitious projects.

Representation and Authenticity are also reasons. Diaspora filmmakers bring authenticity to Nollywood by capturing the images of life abroad. They depict diaspora communities' struggles, triumphs, and cultural clashes. These films challenge stereotypes and broaden Nollywood's portrayal of Nigerians beyond national borders. Audiences witness diverse narratives that reflect their own lives as against the cynicism expressed by Haynes that “the films' establishing shots tend, as in Nollywood, films generally, to be stereotypical rather than exploratory” (2013, p.81). This is to note therefore; that this genre of Nollywood has bestrides such narrow categorization. The defining characteristics of these Nollywood Diaspora films include:

Transnational Settings: These Diaspora films often feature dual locations: Nigeria (the homeland) and the foreign country where Nigerians reside. These settings highlight the cultural encounters, challenges, and identity negotiations faced by characters.

Cultural Encounters and Hybrid Identities: Protagonists navigate the clash between their African heritage and the Western environment. The blend of cultural elements creates hybrid identities and shapes the characters' experiences.

Immigration and Settlement: The films explore the struggles of immigrants, including issues related to undocumented immigration. Characters must make contact with the African expatriate community, which becomes their primary social horizon.

Nollywood, often dubbed the "Hollywood of Africa," has emerged as a global cultural powerhouse. Its films are not only reflections of Nigerian society but also a repository for diasporic identities and experiences. “Present-day Nollywood is a thriving industry and a key component of Nigeria's economy. Churning out over 2,500 films a year, the country's film sector is not just a cultural phenomenon but also a ticket to the world”. (Amokeoja: 2024) For African women navigating diaspora, Nollywood provides a unique platform to explore their intersectional identities, blending humor, drama, and social realities. Films like *30 Days in Atlanta* and *Osuofia in London* exemplify this dynamic, offering windows into the lives of African women as they negotiate displacement, identity, and cultural assimilation. Nollywood's storytelling often intertwines diasporic experiences with themes of identity, belonging, and cultural hybridity. For women, these narratives become even more complex, highlighting their navigation of gender norms within transnational

spaces. Films like *30 Days in Atlanta* and *Osuofia in London* serve as cultural artifacts, reflecting diasporic realities through humor, drama, and social critique. While these films are often celebrated for their comedic elements, a deeper analysis reveals feminist undertones that resonate with the challenges and triumphs of women in the diaspora.

Theoretical Frameworks

Exploring multiple feminist frameworks enriches the analysis of *30 Days in Atlanta* and *Osuofia in London*, providing multiple lenses to understand the films' engagement with gender, diaspora, and identity. Postcolonial, Black, and transnational feminism, as well as ecofeminism and standpoint theory, reveal the layered experiences of African women in Nollywood's diasporic narratives. These frameworks underscore the films' contributions to global feminist discourse, highlighting their power to critique, inspire, and celebrate the resilience of African women.

Kimberlé Crenshaw's Intersectionality

Crenshaw's theory of intersectionality emphasizes how overlapping systems of oppression—such as race, gender, class, and migration—create unique experiences of marginalization. In diasporic contexts, African women often navigate complex intersections that amplify the challenges of displacement, cultural adaptation, and systemic inequality. In *30 Days in Atlanta*, female characters like Kimberly represent the intersection of race, gender, and migration. As an African woman living in the U.S., Kimberly faces racial marginalization as the diaspora narrative highlights implicit racial biases she encounters, though these are nuanced through the comedic lens. Kimberly confronts traditional expectations of African women's roles in relationships and society, choosing autonomy and agency instead of conforming to patriarchal norms. Her ability to seamlessly navigate Western norms while maintaining her African heritage embodies the intersectional pressures of identity. Crenshaw's framework highlights Kimberly's dual challenges: succeeding as a Black woman in a Western, often male-dominated world while maintaining her identity as an African woman. These challenges shape her character's resilience and independence, central to the film's feminist undertones.

In *Osuofia in London*, the women embody intersectionality through their negotiation of cultural and gender roles. The cultural Intersection is obvious as we consider how women in the film are at the crossroads of preserving African traditions, while adapting to London's Western society. This is evident in their interactions with Osuofia, where they subtly resist his patriarchal views. The women

navigate traditional African gender roles while asserting independence within the diaspora, demonstrating how intersectionality complicates their experiences and portrays gender marginalization. Crenshaw's theory helps unpack how these women mediate their multiple identities, showcasing their adaptability and resilience in overcoming the compounded challenges of race, gender, and migration.

Homi Bhabha's Cultural Hybridity

Bhabha's concept of cultural hybridity describes how diasporic identities are formed in the “third space,” where cultures blend and new, hybrid identities emerge. This framework is particularly useful in analyzing how African women in Nollywood diasporic films navigate and redefine their roles across cultural boundaries. In *30 Days in Atlanta*, cultural hybridity is evident in the way African and American cultural norms interact:

Kimberly is portrayed as a hybrid figure. She embodies hybridity through her ability to merge African values with American modernity. For instance, her professional success and independence reflect Western ideals, while her connections to her African roots remain intact. The cross-cultural relationships and the romantic subplot underscores the negotiation of cultural differences. As the characters navigate misunderstandings and cultural clashes, they create new, hybrid dynamics that reflect the “third space” described by Bhabha. The film portrays cultural hybridity as a space of empowerment, where African women can reimagine their identities by blending the strengths of both cultural worlds. Cultural hybridity plays a significant role in *Osuofia in London*, particularly through the women's roles: The women act as cultural mediators, negotiating between Osuofia's traditional African values and the modern Western environment of London. Their ability to operate in this hybrid space highlights their adaptability and agency. The comedic moments, such as Osuofia's struggles to adapt to London, underscore the challenges of cultural hybridity while celebrating the resilience of those who successfully navigate it. Bhabha's “third space” is central to the film's exploration of diaspora, showing how women create and inhabit hybrid identities that transcend rigid cultural boundaries.

Judith Butler's Gender Performativity

Butler's theory of gender performativity argues that gender is not an inherent identity but a set of behaviors performed in accordance with societal expectations. This framework challenges the fixed roles often assigned to women, emphasizing the fluid and constructed nature of gender. In *30 Days in Atlanta*, the portrayal of female characters like Kimberly challenges traditional performances of gender. Kimberly performs gender in ways that defy traditional expectations of African women. Her

assertiveness, independence, and professional success challenge the notion that women's roles are confined to domestic spaces thereby subverting gender norms. Humor is used here as a feminist device. The comedic misunderstandings between Akpos and the women highlight how gender roles are socially constructed. For example, Akpos's outdated views clash with Kimberly's modern perspective, emphasizing that traditional gender performances are subject to critique and reinvention. Butler's theory reveals how *30 Days in Atlanta* uses humor to deconstruct and reimagine gender roles, portraying women as empowered and dynamic individuals.

In *Osuofia in London*, gender performativity is explored through the interactions between Osuofia and the women he encounters. In resisting patriarchy, the women perform gender roles that challenge Osuofia's patriarchal expectations. For instance, their independence and assertiveness contrast sharply with his traditional views, creating comedic tension that critiques gender norms. The women's ability to navigate both African and Western gender expectations underscores the performative nature of gender. They adapt their behaviors to suit different cultural contexts, revealing the fluidity of gender roles. By applying Butler's theory, *Osuofia in London* can be seen as a critique of rigid gender performances, highlighting the agency of women in shaping their identities.

Feminist Standpoint Theory

Nancy Hartsock foundational work on standpoint theory and Sandra Harding's emphasis on marginalized knowledge systems provides a lens for understanding the feminist narratives in diasporic films. This framework argues that marginalized groups, including women, possess unique perspectives that offer critical insights into societal power dynamics. African women's experiences in diaspora provide a distinctive standpoint for analyzing intersectional oppression and cultural hybridity. In both *30 Days in Atlanta* and *Osuofia in London*, women's experiences offer critical insights into gender and cultural power dynamics. Their narratives hints at an understanding of how diaspora reshapes identity. Kimberly's professional success in *30 Days in Atlanta* reflects her ability to leverage her standpoint as an African woman to navigate and succeed in Western spaces.

Postcolonial Feminism

The key proponents of postcolonial feminism like Chandra Talpade Mohanty, whose work in *Under Western Eyes* critiques the homogenization of women's experiences by Western feminism, advocating for a contextual understanding of African women's struggles. In her analysis, Gayatri Chakravorty Spivak, another proponent,

illustrates how her concept of the “subaltern” can be used to analyze how African women in Nollywood films assert their voices despite systemic marginalization in both African and Western societies. Postcolonial feminism critiques the intersection of colonial history, patriarchy, and the marginalization of women in formerly colonized societies. It focuses on how race, culture, and power dynamics shape women's experiences, particularly in the Global South.

In *Osuofia in London*, postcolonial feminism illuminates how African women must navigate the residual impact of colonial structures while asserting their agency in Western spaces. The film's humor often critiques the cultural misunderstandings between African traditions and Western modernity, highlighting women's roles as cultural negotiators. *30 Days in Atlanta* embodies postcolonial feminist ideals by showcasing African women like Kimberly who thrive in diasporic spaces. Her ability to succeed in a predominantly Western society reflects the resilience and empowerment central to postcolonial feminist thought.

Black Feminism

Black feminism specifically addresses the unique struggles faced by Black women, who experience overlapping systems of oppression due to race, gender, and class. This framework emphasizes lived experiences, resilience, and community.

Both films reflect the dual marginalization African women face as women of color in Western societies. For example, in *30 Days in Atlanta*, Kimberly's professional success highlights her ability to overcome barriers in a space where race and gender intersect. In *Osuofia in London*, the women's independence and adaptability align with Black feminist ideals of resilience and resistance against oppressive structures.

Patricia Hill Collins, one of the proponents of this theory, in her concept of the “matrix of domination” helps analyze how African women in these films navigate intersecting power structures, from patriarchy to racial bias. bell hooks, another proponent, discusses how representation and intersectionality are critical for understanding how Nollywood portrays African women's voices in diaspora.

Transnational Feminism

Transnational feminism critiques the universalization of Western feminist ideals, emphasizing the importance of local and global intersections in shaping women's lives. It seeks to understand how migration, globalization, and cross-cultural exchanges influence gender roles. In this vein, Inderpal Grewal and Caren Kaplan, key scholars of this theory, explore in their work on *Scattered Hegemonies* how global power structures intersect with local contexts, offering insights into the

feminist themes in Nollywood diasporic films.

30 Days in Atlanta exemplifies transnational feminism by depicting how African women adapt to and influence Western norms through cross-cultural negotiation. Kimberly's story reflects the challenges and opportunities of living in a globalized world, where gender and culture intersect. In *Osuofia in London*, we are confronted with global networks of power as the experiences of women highlight how globalization creates new opportunities and constraints, shaping diasporic identities within a transnational framework.

Ecofeminism

Vandana Shiva a proponent of Ecofeminism discusses of how preservation and resistance can metaphorically relate to how Nollywood portrays African women as cultural sustainers in diaspora. Ecofeminism draws connections between the oppression of women and the exploitation of nature, emphasizing interconnected systems of domination. Though not directly related to environmental themes, this framework can metaphorically apply to diasporic films by examining how women resist systemic exploitation and sustain cultural “roots.”

In *Osuofia in London*, the women's roles as cultural mediators can be seen as acts of preservation, akin to ecofeminist ideals of sustaining life and legacy. Their adaptability ensures that African traditions thrive in new environments. *30 Days in Atlanta* portrays women as agents of healing and balance, navigating patriarchal and racial challenges to build harmonious transnational identities.

These theories collectively enrich the understanding of feminist narratives in Nollywood diasporic films, illustrating how they engage with global feminist discourse while remaining rooted in African experiences.

Expanding on feminist frameworks offers rich analytical tools to probe deeper into the feminist and diasporic narratives in *30 Days in Atlanta* and *Osuofia in London*.

Despite implausible scenarios, viewers embrace it for the laughs. Generally, *30 Days in Atlanta* celebrates friendship, love, and cultural exploration while delivering an enjoyable and amusing experience.

Visual Style of the film combines colorful cinematography with a mix of urban and natural landscapes. Expect shots of Lagos markets, cityscapes, and lush greenery in Atlanta. James M. Castello's creativity in the cinematography captures both the vibrancy of Lagos, Nigeria, and the allure of Atlanta, Georgia. The director balances aesthetics with humor, creating an enjoyable visual experience that celebrates both Nigerian and American cities, culture, and nuances. *30 Days in Atlanta* weaves together humor, romance, and cultural exploration, making it an enjoyable cinematic experience.

Women and Cultural Adaptation in *Osuofia in London*

This film humorously portrays the journey of Osuofia, a 'village' man, as he navigates the cultural differences between Nigeria and the UK. Although the film centers on a

male protagonist, the female characters offer rich ground for feminist analysis as listed below:

Negotiation of Cultural Identity: The women in the film, particularly those in London, navigate dual expectations—embracing modernity while retaining elements of their African heritage. This reflects the lived experiences of many diasporic women.

Gender Dynamics: The interactions between Osuofia and the women challenge traditional patriarchal attitudes, offering subtle critiques of gender stereotypes.

The film sheds light on the silent labor of women as cultural mediators, showcasing their adaptability and resilience in the face of transnational pressures.

This film humorously juxtaposes traditional African values with Western modernity through the character of Osuofia. While much of the narrative centers on his journey, women play pivotal roles that warrant feminist analysis:

Adaptability in New Spaces: Female characters in the diaspora embody adaptability, serving as mediators between two worlds. Their portrayal reflects the silent labor of women in diasporic contexts, where they balance cultural preservation with assimilation. In what can be termed subtle agency the women's interactions with Osuofia subtly challenge traditional patriarchal narratives, showcasing moments of resistance and autonomy within a comedic framework. Also, there is evidence of representation of feminine resilience as the resilience of women characters highlights their ability to navigate not only the cultural but also the gendered challenges of diaspora life. By placing women in roles of influence, albeit understated, the film underscores their importance in bridging cultural divides.

yet insightful exploration of cultural clashes. The film's portrayal of women introduces themes that align with feminist discourses. Female characters in the diaspora exhibit agency, independence, and the ability to navigate cross-cultural relationships exhibiting Independence and Empowerment. Representing the modern African women, the women in this film embody the complexities of diasporic life, challenging traditional narratives that often restrict African women to domestic roles. By portraying women as active participants in shaping their identities, *30 Days in Atlanta* contributes to the evolving representation of African women in Nollywood. Through its engaging storytelling, *30 Days in Atlanta* positions women as active participants in their own narratives, embodying the essence of feminist empowerment within diasporic contexts.

Cultural Agency: The film portrays diasporic women as individuals with their voices and choices, navigating the intersections of romantic relationships and cultural expectations.

Symbol of Modern African Womanhood: Female characters reflect the evolving role of women in contemporary African societies, blending traditional values with modern aspirations. Their behavior, dress, and career choices emphasize autonomy and empowerment.

Humor as a Feminist Tool

The lighthearted tone of the movie allows feminist themes to be subtly embedded in

its narrative without appearing didactic. Humor is used to critique societal norms, especially around gender roles and cultural stereotypes, making the message accessible to a broad audience. By presenting female characters who assert control in humorous situations, the film breaks down resistance to conversations about gender equality.

Diasporic Identity Through Feminine Perspectives

The film presents a perspective of African women balancing the demands of living abroad while maintaining cultural roots. The juxtaposition of romanticized notions of the diaspora with the realities of life in Atlanta allows the audience to reflect on the complexities of belonging and identity, especially for women.

Comparative Reflection on Feminist Themes

Both films tackle feminist narratives differently but converge on some important points. In both films, women are depicted as agents of cultural and personal transformation, navigating the challenges of diaspora with resilience and agency. Humor is used as a narrative device in both films to soften and amplify conversations about gender, making feminist critiques more accessible to diverse audiences. Both films also address the unique challenges faced by African women in the diaspora, including the intersection of race, gender, and cultural identity. The films also portray the tension between traditional African expectations of women and the opportunities presented by diasporic life.

Both films also portray the role of romance in defining feminist narratives by using romantic subplots to highlight and challenge traditional views of love and gender roles. Since Nollywood diasporic films often center on the experiences of African migrants, including the dual challenges faced by women, these films highlight themes such as cultural adaptation where diasporic women must navigate the tension between preserving their African heritage and adapting to Western norms. This duality often places them in a position of cultural mediators. Diasporic narratives frequently portray women as resilient figures, redefining their identities in foreign environments. Critique of Feminist Representations

Despite their contributions, both *Osuofia in London* and *30 Days in Atlanta* face critiques regarding their portrayal of women. The comedic tone sometimes

simplifies complex gender issues, risking the perpetuation of stereotypes. Female characters, while empowered, often occupy secondary roles, reflecting the male-centric focus of many Nollywood narratives. There is limited diversity in representation, as the portrayal of women in these films may not fully capture the diverse realities of African diasporic women. These critiques highlight the need for more nuanced and central feminist portrayals in Nollywood's diasporic films. Acknowledging these limitations is crucial for Nollywood to deepen its engagement with feminist storytelling and ensure more diverse, central portrayals of women's experiences.

Conclusion

Through films like *30 Days in Atlanta* and *Osuofia in London*, Nollywood engages with diasporic themes while embedding subtle feminist narratives. By presenting women as resilient, adaptable, and independent, these films contribute to the discourse on African diasporic literature and film. However, continued efforts are necessary to ensure that feminist narratives occupy central spaces in Nollywood's evolving storytelling. Through *30 Days in Atlanta* and *Osuofia in London*, Nollywood provides a degree of exploration of the diaspora, women, and feminist narratives. While the contributions are significant, the industry must continue to evolve, addressing critiques and expanding its portrayal of feminist narratives to better reflect the diversity of African diasporic women. As Nollywood grows, its ability to amplify these voices will remain pivotal in shaping the global discourse on African diasporic literature and film.

30 Days in Atlanta and *Osuofia in London* exemplify Nollywood's capacity to engage with feminist and diasporic narratives while maintaining its characteristic humor and relatability. These films celebrate the resilience, agency, and adaptability of African women in diaspora, offering insights into the intersectionality of gender, culture, and migration. However, their limitations underscore the need for continued evolution in Nollywood's portrayal of women, ensuring that feminist narratives occupy more central and diverse spaces in African cinema. By engaging with the feminist undertones of these films, we can better understand how Nollywood contributes to the global discourse on gender, identity, and diaspora. These cinematic works serve as cultural touchstones, bridging the gap between African and diasporic realities, and amplifying the voices of African women in the global cultural landscape.

By grounding the analysis of these films in multiple theoretical frameworks,

comparative insights, and cultural critique, a more focused exploration of feminist and diasporic narratives in *30 Days in Atlanta* and *Osuofia in London*. These elements enrich the understanding of how Nollywood films contribute to global feminist discourse and redefine African identities in transnational spaces. Nollywood diasporic films, when analyzed through a feminist lens, offer a rich tapestry of narratives that reflect the complexities of gender and migration. These films celebrate the resilience and agency of African women while critiquing the societal norms that seek to constrain them. By continuing to challenge stereotypes and broaden representations, Nollywood can further its role as a powerful medium for feminist storytelling, bridging the gap between African and diasporic realities.

Through a feminist lens, *30 Days in Atlanta* and *Osuofia in London* offer narratives that celebrate the resilience and agency of African women in diaspora. By engaging with theoretical frameworks like intersectionality, cultural hybridity, and gender performativity, these films contribute to a deeper understanding of gender dynamics and diasporic challenges. While their limitations highlight areas for improvement, their achievements in amplifying feminist voices and critiquing societal norms underscore Nollywood's role as a powerful medium for feminist storytelling.
